At a duly convened meeting the following motion was passed by a quorum of Council:

RE: Declaration of Local State of Emergency Due to Atmospheric Flooding Event

WHEREAS there is **Atmospheric Flooding Event** in close proximity to the Cook's Ferry Indian Band reserves;

AND WHEREAS there is imminent threat to life or property;

AND WHEREAS this **Atmospheric Flooding Event** requires prompt coordination of action or special regulation of persons or property to protect the health, safety or welfare of people or to limit damage to property;

NOW THEREFORE BE IT RESOLVED the Chief and Council of Cook's Ferry Indian Band declare a Local State of Emergency.

IT IS HEREBY ORDERED THAT the Cook's Ferry Indian Band employees, servants and agents are empowered by a duly signed Band Council Resolution to do all acts and implement all procedures that are considered necessary to prevent or to alleviate the effects of the emergency, including:

- Acquire or use any land or personal property considered necessary to prevent, respond to or alleviate the effects of an emergency or disaster.
- Authorize or require any person to render assistance of a type that the person is qualified to provide or that otherwise is or may be required to prevent, respond to or alleviate the effects of an emergency or disaster.
- Control or prohibit travel to or from any area designated in the declaration within the local authority's jurisdiction.
- Provide for the restoration of essential facilities and the distribution of essential supplies and provide, maintain and coordinate emergency medical, welfare and other essential services in any part of the local authority's jurisdiction.
